Re: Proposed Increase in Lunch Prices for FY '18

Consistent with our Strategic Objectives 2016-2018, I am pleased to provide the committee with some research regarding lunch prices and make an initial recommendation regarding a proposed modest increase for FY '18. Initiative #4 of Objective #3: Sustainable Funding states, "Evaluate current food costs, compare with industry standards and surrounding town information to recommend possible increase in meal costs."

Currently we charge, \$2.60 for an elementary lunch (K-4), \$2.85 for a secondary lunch (5-12) and \$3.85 for an adult lunch. These prices were put into effect on July 1, 2014 and have remained consistent for three years. Based on comparisons with surrounding towns, federal minimum standards, an analysis of meals per labor hour, and the current fiscal condition of the Food Services Department, we are recommending a 15 cent increase in prices across the board for FY '18 beginning in September, 2017. As a result, the proposed prices would be \$2.75 (K-4), \$3.00 (5-12), and \$4.00 for an adult lunch. Breakfast prices would remain the same.

On February 1, Lynn Petrowski, Food Services Director, will present on the proposed increase and provide a full explanation and rationale. I am providing a comparison of surrounding towns for your information at this time and will ask for consideration and a vote on the proposed change after Lynn's presentation.

## Paid Lunch Equity

• A provision of the Healthy Hunger Free Kids Act of 2010, which reauthorized child nutrition programs.

Regulations at 7 CFR 210.14 require school food authorities to ensure sufficient funds are provided to the non-profit school food service account for meals served to students not eligible for free or reduced price meals.

## Paid Lunch Equity

- SFA's must, on average, charge for paid lunches at least the difference between the federal reimbursements for free and paid lunch
- \$2.51 for SY 2012-13
- \$2.59 for SY 2013-14
- \$2.65 for SY 2014-15
- \$2.70 for SY 2015-16
- \$2.78 for SY 2016-17
