- Question by Lynch- Have other students in the area been on this trip? Response that Mr. Perry has been in contact with other teachers/towns that have been and the response is very positive

- Motion by Phillips to accept donations in the amount of \$8,756.61. The motion was seconded by Corbo. The motion carried unanimously.

Report of Superintendent:

District Events and Updates

- Friends of Hanover Elementary Schools had a fundraiser at Pembroke Country Club last weekend- Donations from fundraising event is around \$48,000.00
- Intention is to work with the parents to put together a small advisory group (including parents, teachers, technology etc.) to look at the opportunities that this money could create for students
- Comment by Marriner that the School Committee would like the money validated to make sure its spend equitably between elementary schools and they may vote to approve it conditionally
- Town Manager is presenting State of Town Address at Town Hall, tomorrow at 7:30 am
- Mr. Ferron spoke with Bob Murray about high school fields- baseball field is being evaluated and schedule is still to be completed by first pitch of season
- Track & Field Events- Conservation Commission meeting was snowed out and is now rescheduled for Feb. 19th. There is a Plan B if the Conservation
- Question by Corbo- did we follow up with the softball field? Internally they followed up with softball coach and there is no issue with foul balls in the tennis court
- Mr. Ferron spoke in regards to Dr. Raab's Proposed Community Service Requirement for 40 hours over 4 year
- This will be addressed further next week at his proposed studies changes/requirements

MSBA Update- Center/Sylvester

-We were contacted by the Project Coordinator to set up a conference call with him

- Town Manager was able to find a Funding source for feasibility study

- Need to create a building committee for this and a School Committee Representative will be required

- Question by Phillips regarding how much a feasibility study would cost? Response by Mr. Ferron that Mr. Clarkson has set aside about \$500,000.00

Town Manager's FY15 Budget Submission Breakdown for HPS

- Town budget was presented for the town last week
- Town Manager Recommendation for Operating side budget for HPS is \$24,027,579.00
- Warrant Article for Special Education Relief in the amount of \$300,000.00
- Public Hearing for budget will be March 5, 2014
- Gap between Level Service Budget and Town Manager's budget is around \$345,000.00
- Gap between HPS needs budget and Town Manager's budget is around \$900,000.00
- Comment by Corbo that if we could see a presentation that if the Town Manager's Budget stands and we have a deficit of \$345,000.00- how would that impact the students?
- Mr. Rowe applied for relief for extraordinary funds through state and Ms. Shea may apply for relief under special education costs

Report of Finance Department:

FY15 Budget Update

- Already covered under other categories

Per Pupil Expenditure

- FY 11 and FY12 Per Pupil Spending by DESE was provided- FY13 has not been released yet
- Its broken down by category and shows where Hanover stands in relation to like districts as identified by DESE
- Overall Hanover ranks 10th out of the 11 towns presented
- One reason Hanover is low on the list is the insurance/retirement category-Hanover has a 50/50 split between employees and town

Report on Teaching & Learning

Full Day Kindergarten Update

- Completed kindergarten registration today
- Center- 68 students for full day, 32 for half day
- Cedar -33 students for full day, 20 for half day
- Cedar has 40 full day slots and Center has 60 full day slots
- Center- Out of 32 students for half day-20 would use SCORE program for 2-5 days
- Cedar Out of 20 students for half day-13 would use SCORE program for 2-5 days

- Comment by Corbo -Nominations for school committee papers are due March 24 or 28th with signatures

Motion by Corbo to enter executive session to discuss litigation strategy only to return to open session for adjournment.
