Re: FY 2020 Budget Transfer Request

Please find attached requested transfers from the Annual Town Meeting approved FY 2020 School Department Budget. While the total FY 2020 budget amount of \$29,218,267 remains the same, I am respectfully requesting that the School Committee approve these transfers. They accurately reflect current salary and expense obligations that have changed since the budget was voted on March 13, 2019 and approved at Town Meeting in May 2019.

Overall, we've realized an additional \$258,183 in out of district tuition liability since March. While there were saving opportunities within Salaries and Expenses, these were not enough to cover the additional expenses. I also expect to use \$57,131 of FY 2019 Circuit Breaker carryover as well as \$100,000 of the Annual Town Meeting Special Education Reserve Article in order to balance the budget for FY 2020. As in the past, I will not request votes of the School Committee and the Board of Selectmen for the \$100,000 until June once I know exactly what is necessary to transfer to balance the budget.

Below is a chart summarizing the budget by category. Attached to this memo are the individual lines affected by the transfer. I respectfully request that the School Committee vote to approve the line item transfers attached.
